A BILL TO AUTHORIZE THE PAYMENT OF A  
GOLDEN JUBILEE MONETARY GIFT TO  
RECIPIENTS OF CERTAIN PENSIONS AND  
ALLOWANCES

NOTE

This Bill, which is entitled "*The Golden Jubilee Special Allowance Act*", authorizes the payment of a special jubilee allowance of fifty dollars to recipients of pensions or allowances under *The Supplementary Allowances Act*, *The Disabled Persons Act*, *The Disabled Persons' Pensions Act*, *The Mothers' Allowance Act* or *The Widows' Pensions Act*.

This Bill also authorizes the payment of the allowance to recipients of the War Veterans' Allowances, and to recipients of the dependent parents pension under section 38 of the *Pension Act* (Canada).

This Bill comes into force upon assent.

# BILL

An Act to Authorize the Payment of a Golden Jubilee  
Monetary Gift to Recipients of Certain Pensions  
and Allowances

**H**ER MAJESTY, by and with the advice and consent of  
the Legislative Assembly of the Province of Alberta,  
enacts as follows:

**1.** This Act may be cited as "*The Golden Jubilee Special Allowance Act*". Short title

**2.** (1) For the month of September, 1955, the Minister Payments  
of Public Welfare may provide for the payment of a special  
jubilee allowance of fifty dollars to any person who is, on  
the first day of September, 1955, in receipt of an allowance  
or pension under any of the following Acts, namely,

- (a) *The Supplementary Allowances Act*,
- (b) *The Widows' Pensions Act*,
- (c) *The Disabled Persons Act*,
- (d) *The Disabled Persons' Pensions Act*,
- (e) *The Mothers' Allowance Act*.

(2) The special jubilee allowance shall be in addition to  
the allowance or pension payable to the recipient, under any  
of the Acts mentioned in subsection (1), for the month of  
September, 1955.

**3.** The Minister of Public Welfare may also provide for Payments  
the payment of a special jubilee allowance of fifty dollars  
to any person who is, on the first day of September, 1955,  
in receipt of an allowance under the *War Veterans Allow-*  
*ance Act, 1952* (Canada) or a pension under section 38 of  
the *Pension Act* (Canada).

**4.** The moneys required for the purposes of this Act shall Appropriation  
be paid out of the General Revenue Fund.

**5.** This Act comes into force on the day upon which it Coming into force  
is assented to.
