525. Ms Lovely to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) recognize that residents of rural communities and farm owners in Alberta face unique challenges related to crime, including property theft, vandalism and personal safety, and
- (b) urge the Government of Canada to introduce legislation to provide more legal certainty for individuals who are required to use force to defend themselves, their families and their property.

528. MLA Tejada to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to immediately engage with the Government of Canada to consider the following:

- (a) providing additional funding to address the increased cost of delivering the following public services as a result of Alberta's growing population:
 - (i) health care,
 - (ii) Early Childhood Services (ECS) until Grade 12,
 - (iii) post-secondary education,
 - (iv) emergency services, and
 - (v) newcomer support services;
- (b) entering into a federal-Alberta partnership to streamline the coordination of settlement and integration services for newcomers.

529. Hon. MLA Ceci to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government to consider taking the necessary steps to ensure that arts education and arts-based learning opportunities, including music, theatre, and art lessons, are accessible to Alberta families through school and community-based opportunities by eliminating financial barriers to participation in arts programming, including ensuring that the funding parameters of the Every Kid Can Play Program grant explicitly includes art-related activities.

530. MLA Hoyle to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) acknowledge the importance of access to a nearby hospital for the residents of south Edmonton, and
- (b) urge the Government to consider taking the necessary steps to build a new hospital in south Edmonton.

534. Mr. Wright to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) express its view that the Alberta Legislature has the exclusive power to legislate with respect to property rights, as described in the division of powers set out in sections 91 and 92 of The Constitution Act, 1867, including laws governing firearms ownership,
- (b) recognize that firearms are tools necessary to preserve life, property and economic livelihoods for those Albertans involved in economic activity such as farming, ranching and resource extraction, all of which entail close contact with wildlife given Alberta's vast wilderness, and
- (c) urge the Government of Canada
 - (i) to terminate the Canadian Firearms Program (CEP), and
 - (ii) to work collaboratively with provincial governments to take all necessary steps to amend The Constitution Act, 1867 to transfer all power to legislate with respect to firearms from the Parliament of Canada to provincial legislatures.

535. Mr. Wiebe to propose the following motion:

Be it resolved that the Legislative Assembly

- (a) recognize that the Public Sector Compensation Transparency Act serves as an important tool in ensuring transparency in government spending and public sector compensation and fosters trust among government entities and the communities they serve, and

- (b) urge the Government to introduce a Bill to amend the Public Sector Compensation Transparency Act to require municipal authorities to disclose their employees' compensation in accordance with the thresholds for optional disclosure currently set out in the Act in respect of those employees.

540. Mr. Rowswell to propose the following motion:

Be it resolved that the Legislative Assembly urge the Government of Alberta and the Government of Canada to reassess their utilization of carbon credit programs to incentivize efforts to reduce greenhouse gas emissions in Alberta.
