On request by Mr. Yankowsky, Hon. Member for Edmonton-Beverly-Clareview, the following petition was read and received:

We, the undersigned residents of Alberta, petition the Legislative Assembly of Alberta to urge the Government of Alberta to introduce amendments to the Human Rights, Citizenship and Multiculturalism Act to allow Alberta health professionals to opt out of those medical procedures that offend a tenet of their religion, or their belief that human life is sacred.

Mr. Speaker, in accordance with Standing Order 94, the Standing Committee on Private Bills has reviewed the petitions that were presented Monday, April 30, 2001, and can advise the House that all but 2 of the petitions comply with Standing Orders 85 to 89.

The Committee has considered the remaining petitions and recommends to the Assembly that Standing Order 89(1)(b) be waived for the petition for Congregation of the Most Holy Redeemer Amendment Act, 2001, subject to the petitioner completing the necessary advertising before the Committee hears the petitioner. The Committee also recommends that the petition for Western Union Insurance Company Amendment Act, 2001, be deemed to have satisfied the requirements for advertising under Standing Order 86(1)(b).
