### **Speaker's Statement — Member's Anniversary**

### **Presenting Petitions**

Hon. Mr. Sabir, Hon. Member for Calgary-Bhullar-McCall, presented a petition from 86 Albertans urging the Government to (1) introduce legislation to create a provincial entity that would have the rights of a “public passenger service provider” as defined in the Canada Transportation Act, with the mandate to develop and operate commuter rail within the Province of Alberta; (2) consider allocating funding to develop and operate a frequent and reliable commuter rail service serving Okotoks, Calgary, Airdrie, Red Deer, Leduc, Edmonton and points between with fares that would be affordable to the majority of Albertans; (3) introduce legislation to protect the rights of rail passengers and allow the government to define performance standards for the timely operation of such a commuter rail service.

Mr. Shepherd, Hon. Member for Edmonton-City Centre, presented a petition from 326 Albertans urging the Legislative Assembly to recognize the harm that would be caused to Albertans by the Government doing the following: (a) imposing age restrictions on receiving gender affirming surgery or hormone therapies by transgender youth; (b) requiring parental notification or permission before allowing a student to be referred to by their preferred name or pronouns at school; (c) prohibiting teachers and school boards from referring to the concepts of gender identity, sexual orientation or sexuality in any lesson provided to students without the prior written approval of a student's parent.
